ANNUAL PRECINCT BUDGET MEETING - MONDAY, MARCH 16, 2026

TO THE INHABITANTS OF THE SANBORNVILLE PRECINCT, IN THE TOWN OF WAKEFIELD, N.H., QUALIFIED TO VOTE IN PRECINCT AFFAIRS, YOU ARE HEREBY NOTIFIED TO MEET AT THE TOWN HALL CONFERENCE ROOM, 2 HIGH ST SANBORNVILLE NH, ON THE 7TH DAY OF APRIL 2026, AT 6:00 P.M., TO VOTE ON THE FOLLOWING ARTICLES.

ARTICLE 1: To elect a Moderator for one year.  
To elect a Clerk/Water Rent Collector for one year.  
To elect a Treasurer for one year.  
To elect a Water Commissioner for two years.  
To elect a Water Commissioner for three years.

ARTICLE 2: To see if the Sanbornville Precinct will vote to change the purpose of the Existing Water Main Capital Reserve Fund to the Water Distribution System Capital Reserve Fund as previously established to include Repair, Replacement, Purchase of supplies, Expansion of said Water Infrastructure and Pay any Associated Debt Services. Further, to name the Commissioners as agents to expend from said funds. Recommendations by the Commissioners (3 of 3), Required (2/3 vote required).

ARTICLE 3: To see if the Sanbornville Precinct will vote to raise and appropriate the sum of \$50,000 to be added to the Emergency Repairs Capital Reserve Fund previously established. The sum of \$50,000 to come from user fees, no amount from taxation. Recommended by the commissioners (3 of 3) and the Budget Committee.

ARTICLE 4: To see if the village district will vote to raise and appropriate the budget committee recommended sum of \$347,905 for general municipal operations. The sum of \$313,402 is to come from user fees and \$34,503. from unassigned fund balance with no amount from taxation. This article does not include appropriations contained in special or individual articles addressed separately. Recommended by the commissioners (3 of 3) and the Budget Committee.

ARTICLE 5: To transact any other business that may legally come before this meeting.


